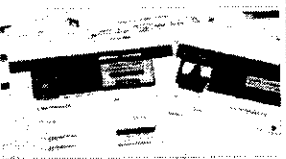

# Facebook auto-generating pages for IS, al-Qaida

IN THE FACE of evidence that Facebook is not doing enough to combat extremist messaging, the company has to say that its automated systems have now the vast majority of prohibited content glorifying the Islamic State group and al-Qaida before it is reported.

But a whistleblower's complaint shows that Facebook itself has mysteriously provided those extremist groups with a networking and recruitment tool by producing dozens of pages in their names.

The social networking company appears to have made little progress so far. In the four months since the *Washington Post* detailed how pages that Facebook auto-generates for businesses are aiding al-Qaida extremists and white supremacists in the United States.

On Wednesday, 116 members of the committee on Commerce, Science, and Transportation will be questioning representatives from social media companies, including Microsoft, Facebook, and Twitter. The new legislation from an update of a committee on Commerce and Transportation that the National Intelligence Council plans to file this week. The flag obtained by the AP identifies almost 200 auto-generated pages — some for businesses, others for schools or other categories — that directly reference the Islamic State group and does more representing al-Qaida and other known groups. The page lists the names of the pages, their categories, and their content. It also lists the names of the people who created the pages, and their contact information.

Facebook has been working to limit the spread of extremist material on its service, so far with mixed success. In March, it expanded its definition of prohibited content to include US white nationalist and white separatist material as well as that from its extremist extremist groups. It says it has banned 200 white supremacist organizations and is willing to provide content related to global extremist groups like IS and al-Qaida.

The new listing also found that users' pages promoting extremist groups remain open in their names. They uncovered a page for "Mohammed Atta" with a home photo of one of the al-Qaida terrorists, who was a student in the September 11 attacks. The page lists the user's work at "Al Quidah" and "University of Education" and "School 2".

It also expanded its definition of terrorism to include not just acts of violence but also acts of political or ideological acts, but also attempts at violence, especially when aimed at civilians with the intent to coerce and intimidate. If unclear, though, how well enforcement works in finding its platforms of well-known extremist organizations and supporters.

In response to a request for comment, a Facebook

spokesperson told the AP "our priority is detecting and removing content posted by people that violates our policy against harassment, hate speech, and regulations to stay ahead of bad actors."
